BMC TO RELEASE THE PULSE, A 2024 REGIONAL ISSUES SURVEY

The Baltimore Metropolitan Council (BMC) is preparing to release The Pulse, an inaugural survey of critical policy issues providing an unprecedented portrait to help guide the region's planning and decision making in the months and years ahead. Media are invited to join a briefing on **Tuesday, October 1 at 8:00 am**

Unique among polling conducted in the Baltimore region, The Pulse includes a sufficient sample size that yields statistically valid results for each of the seven jurisdictions in the metropolitan area: Baltimore City and Baltimore, Anne Arundel, Carroll, Harford, Howard and Queen Anne's Counties.

Survey results provide insight on the views of the region's residents on the economy and personal finances, housing and development, traffic and transportation, as well as emerging topics such as the Harborplace redevelopment, Key Bridge reconstruction and the Red Line transit connection.
